



## LICENSE AGREEMENT FOR GEMVISION SOFTWARE

Your use of Gemvision software is based on the software license and other terms and conditions as they apply to the product at the time of purchase. Your approval of these terms and conditions is required for the installation or use of the product. The software license at the time of purchase can differ from the license version you can see here.

Please read this software license agreement ("License") carefully before using the Gemvision software ("Software"). By using the Software, you agree to these terms and conditions of the License and the relevant general terms and conditions of Gemvision. If you do not agree to the terms and conditions of this License, you must not use the Software and you must select the "I do not agree" button, if the buttons "I agree" and "I do not agree" are shown.

**IMPORTANT NOTE:** Insofar as it is permitted to use this software for the reproduction, alteration, publication or distribution of material, this License is exclusively made available to you for the reproduction, alteration, publication and distribution of material that are not subject to copy rights, material for which you own the copy right or material for the reproduction, alteration, publication or distribution for which you have obtained permission or in respect of which you hold a legal right. If you are unsure of your rights to copy, alter, publish or distribute any material, you must consult your legal advisor.

### **1. General.**

A. The Software and all software of other manufacturers, the material, the documentation, the interfaces, the fonts and the data to this License, either pre-installed on hardware, on disk, in "read only" memory or on any other medium or in any other form (jointly referred to as "Software"), are given to you in license, not sold, by AR-Development B.V., under the trade name Gemvision ("Gemvision"), for the exclusive use under the terms and conditions of this License. Gemvision and/or its licensors retain the property right with regard to the Gemvision software and retain all rights that have not explicitly been awarded to you.

B. Gemvision may, at its discretion, deliver future upgrades or updates for the Software. If you originally purchased a license for a version of the Software, it is possible for Gemvision to provide you with any software upgrades or updates for free.

C. The intellectual property rights and other property rights to the material that is shown or accessed with the aid of the Software is held by the owner in question. Such material is possibly protected by a copyright legislation or any other legal provisions and Conventions with regard to intellectual property rights and is possibly subject to the terms of use of the party supplying the material. Unless otherwise stated in this License, this License does not grant you any rights for the use of such material, nor does it guarantee that such material will remain at your disposal.

### **2. Permitted use and limitations.**

A. License. On the basis of the terms and conditions stated in this License, you have the right to use the Software and you are granted a limited, non-transferable, non-exclusive License to download, install, use and run one (1) copy of the Software directly for use on one (1) hardware product deemed appropriate for this purpose by Gemvision, which you own or have under your control.

B. System requirements. The Software is only supported by hardware that meets the system requirements stated by Gemvision.

C. Main agreement. If you obtained the Software as part of a collaboration agreement, a development or maintenance agreement or any other framework agreement including appendices, of which the license agreement forms part ("Main agreement"), the terms and conditions of the Main agreement will determine the number of copies of the Software you are permitted to download, install, use and run on hardware you own or control. Except insofar as permitted in writing by Gemvision, all other terms and conditions and limitations resulting from this License apply to the use of the Software that has been acquired as part of a Main agreement.

D. Other limitations of use. The rights you are granted by way of this License, do not include the right to install, use or run the Software on a hardware product which has been deemed unsuitable for this purpose by Gemvision and you agree to refrain from doing so and shall also refrain from enabling others to do so. Unless this is otherwise permitted by the terms and conditions of this License: (i) only one user at a time can use the Software at any time, and (ii) you are not permitted to make the Software available via a network if this would enable the simultaneous use or running of the Software on multiple hardware devices. You are not permitted to (enable) the renting, (enable) the leasing, (enable) the giving into use, the sale, the redistribution or the sublicensing.

E. Open Source. If there are certain Open Source components of the Software or Open Source programs of other manufacturers that are delivered, have been or can be made available by Gemvision along with the Software (jointly referred to as the "Open Source components"), then you are permitted to only alter or replace these Open Source components, provided: (i) the "Altered Software" resulting from the adjustment is used instead of the unaltered Software on the appropriate hardware you own or control, for as long as a licensed copy of the Software is present on this hardware; and (ii) you meet the other terms and conditions of this License and any other license terms and conditions that apply to the use of the Open Source components. Gemvision is not obliged to provide support for updates, maintenance, support that is covered by the guarantee, technical support or any other support for the Altered Software resulting from the adjustment. You explicitly acknowledge that problems with or damage to hardware as a result of the altering of the Open Source components of the Software is excluded from the provisions of the Gemvision guarantee.

F. No reverse engineering. You are aware and agree that you are not permitted and that you will not enable others to copy, decompile, reverse engineer the design, dismantle, alter or decode or adjust the Software, or any service offered by Gemvision or any part thereof (unless insofar as this is explicitly permitted under this License or by the usage rules as they apply to you) or to try to deduce the source code of or create derived works on the basis of the above-mentioned Software, services or parts thereof (except if and insofar as any of the above-mentioned limitations is forbidden on the basis of the applicable legislation or of the license terms and conditions with regard to the use of the Open Source components that are possibly included in the Software).

G. Compliance with legislation and regulations. This information is collected periodically for the purposes of offering software updates, product support and other Software-related services (if applicable) and to check whether the terms and conditions of this License are complied with. Gemvision may use this information for the purposes of delivering or improving the products and services provided by Gemvision, insofar it is collected in such a manner that you cannot personally be identified. Gemvision has the right to provide partners or independent developers that diagnostic information that is relevant for the software, hardware and/or services of that partner or developer, for the purposes of enabling those partners or independent developers to improve their software, hardware or the services they have developed for use in combination with the Gemvision

products, provided this information is made available in a form that does not allow you to be personally identified.

B. Location details. Gemvision, the partners and licensees of Gemvision and independent developers are permitted to provide certain services via the Software based on your location data. Gemvision, the partners and licensees of Gemvision and the developers of other manufacturers are permitted to send, collect, manage, process and use your location data for the provision of such services, if available. Any adjustments or alterations of this License shall only be valid insofar as these have been drawn up in writing and have been signed by Gemvision. Translations of this License have been made for the purposes of meeting local requirements. In the event of a difference between the Dutch and the foreign version, then the Dutch version of this License shall apply insofar as this has not been prohibited by local legislation applicable in your jurisdiction.
